A draft finding of no significant impact (FONSI) was issued by the Idaho Department of Environmental Quality (DEQ) on November 10, 2015 for the City of Franklin's (City's) wastewater treatment improvements based on a careful review of the environmental information document prepared by J-U-B Engineers, Inc.

The draft FONSI was published in both English and Spanish on November 18, 2015 in *The Preston Citizen*, newspaper of record for the City. No comments were received during the 30-day public comment period following publication. Therefore, the record of decision for the City of Franklin's wastewater treatment improvements, a FONSI, is final.
